Nasdaq Commodities Oslo, October 1st, 2021

Power Trading Results

In September 2021, the total volume in power derivatives traded and cleared on Nasdaq Commodities amounted to 83.9 TWh. The share of Order Book traded power was 50.8 TWh which includes 1.3 TWh from German Power.

Electricity Certificates Trading Results

In September 2021, the total volume of traded and cleared Electricity Certificates was 44 thousand El-Certs.

Carbon Trading Results In September 2021, the total volume of traded and cleared EUAs was 245 thousand tonnes.
