In July 2022, the total volume in power derivatives traded and cleared on Nasdaq Commodities amounted to 19.5 TWh. The share of Order Book traded power was 8.4 TWh which includes 0.2 TWh from German Power.

In July 2022, the total volume of traded and cleared Electricity Certificates was 189 thousand EI-Certs.

Carbon Trading Results

In July 2022, the total volume of traded and cleared EUAs was 23 thousand tonnes.
