1 Overview

Nasdaq Nordic¹ plans to introduce **PureStream** trading to the European market during 2025, **pending regulatory approval**.

PureStream on Nasdaq Europe is a volume-based trajectory trading facility designed to minimize market impact while maximizing liquidity from equal counterparts.

PureStream matches Indications of Interest (IOIs) based on liquidity transfer rates (LTR). This allows institutional investors to minimize market impact and automate execution of trading interests by trading a percentage of the market's future volume at the market's Volume-Weighted Average Price (VWAP).

IOIs are matched with one or multiple another PureStream IOIs based on the specified LTR, instead of a specific price. LTR indicates the percentage of volume (e.g., 20%) of Benchmark Trades a user is willing to trade. When IOIs are firmed-up and matched, Streams are established which are not published (not sent on market data feeds like ITCH/NLS).

When a set of Benchmark Trades occur (e.g. total of 10,000 shares), a PureStream Trade is executed in a Stream based on their LTR-rate (10,000 shares * 20% = 2,000 shares) at VWAP and published in real time as negotiated trade via NLS and GCF/tip feeds.

1.1 Purpose of document

The purpose of this document is to present the Draft changes to the protocol specifications to help members and ISVs to prepare for the implementation (note it can be subject to change).

The service will be available both on FIX and OUCH.

While the concept of IOI messaging is explained in detail, generally IOIs are referenced as orders.

Note that the launch of the PureStream service is pending regulatory approval.

The Order Book directory message is described in the TotalView-ITCH protocol specification but also applicable for the Nasdaq Nordic Last Sale (NLS) feed. PureStream negotiated VWAP trades, are published on NLS and GCF/TIP feeds, not on ITCH.
