NASDAQ OMX Commodities and N2EX Physical Power

Oslo, 4 August 2014

## **Power Trading Results in July 2014:**

In July 2014, the total volume in power derivatives cleared on NASDAQ OMX Commodities amounted to 88.3 TWh (July 2013: 82.0 TWh). The share traded on the exchange, NASDAQ OMX Commodities Europe, was 53.7 TWh (July 2013: 42.3 TWh). The total volume includes 4.9 TWh from German Power. (July 2013: 0.7 TWh).

In July 2014, physical power trading on the N2EX market accounted for a total of 10,729 GWh (July 2013 11,187 GWh). The total volume includes 10,729 GWh from the Auction Market and 1 GWh from the Prompt Market (July 2013: 10,995 GWh/192 GWh).

## **Carbon Trading Results in July 2014**

In July 2014 the total volume of traded and cleared EUAs and CERs was 0.6 million tonnes as compared to 0.3 million tonnes in July 2013.
