Power Trading Results in January 2017

In January 2017, the total volume in power derivatives traded and cleared on Nasdaq Commodities amounted to 131.7 TWh (January 2016: 157.5 TWh). The share of Order Book traded power was 71.5 TWh (January 2016: 90.8 TWh) which includes 11.8 TWh from German Power (January 2016: 14.9 TWh).

Carbon Trading Results in January 2017

In January 2017 the total volume of traded and cleared EUAs and CERs was 0.03 million tonnes as compared to 0.54 million tonnes in January 2016.
