Power Trading Results in April 2019

In April 2019, the total volume in power derivatives traded and cleared on Nasdaq Commodities amounted to 56.4 TWh. The share of Order Book traded power was 28.2 TWh which includes 1.3 TWh from German Power.

Electricity Certificates Trading Results in April 2019

In April 2019 the total volume of traded and cleared Electricity Certificates was 1.55 million EI-Certs.

Carbon Trading Results in April 2019

In April 2019 the total volume of traded and cleared EUAs was 0.155 million tonnes.
